5. Participants

Participants who meet the following conditions may take part in the Seminar:

- a) Administrative staff from the NUSF or sub-regional federations;
- b) At maximum, 4 participants will be accepted from one member federation. Considering the gender equality, two females and two males are encouraged.

Note: all the lecturers will be given in English. Participants must be fluent in English.

6. Financial Conditions

- a) Participation fee
 - The Organizing Committee will cover the local costs of maximum 2 participants from one member federation. For extra participant, the maximum amount of \$750 (Australia Dollar) will be charged per person.
 - The payment could be paid via credit card, cash or technical transfer. Bank information will be provided in the details with an invoice.
- b) Registration Fee
 - USD10 per person (for AUSF and FISU-Oceania members);
 - USD20 per person (for Non-AUSF and FISU-Oceania members).
 - The Registration Fee must be paid by cash upon arrival, which will be collected by AUSF.

7. Registration process

Delegates will be asked to register via the official online registration portal of the Seminar. Registrations will open in June and all NUSFs will be provided with a link to the registration system. Participants will be able to register their details, meal requirements and make payments as required. Instructions for the registration process will also be provided.

8. Accommodation

 - To encourage the communication, participants of the same gender from different member federations may share the room.

8. Official airport and transportation

The local airport is Gold Coast Airport, located in Coolangatta. Gold Coast Airport has some direct flights to Asia and Oceania destinations. Gold Coast Airport is 20 minutes from Bond University and the seminar accommodation.

Brisbane International Airport is the closest capital city International Airport and many international flights may fly into this destination. Brisbane International Airport is 1.5 hours from Bond University and the seminar accommodation.

Note that if your flight arrives at Sydney International Airport, you will then be required to take a domestic flight to the Gold Coast Airport.

It is recommended that you fly into Brisbane International Airport or Gold Coast Airport. You will be able to provide your arrival airport as a part of your registration process.

Transport from the official airport to the hotel will be provided by the Local Organizing Committee.
